# Contract

Exhibitor will abide by and be subject to the following agreement as a condition for acceptance as an exhibitor at The Christmas Festival.

1. All crafts to be displayed at my booth at The Christmas Festival are my own creation or that of my family.
2. I will not sublet booth space nor act as dealer to other craftsmen or manufacturers.
3. I understand that the promoter reserves the right to remove, without refund or recourse, any exhibitor who misrepresents themselves or their product.
4. I agree to comply with all local and state regulations. I will have no open flames unless I receive written permission in advance of the show.
5. I will obtain all tax, vendor or other permits as required by local or state authorities at my own expense.
6. I understand that sale signs are prohibited and that I must store excess stock out of sight, and that I agree to abide by move-in and move-out regulations as stipulated by the promoter. I further agree to remain set up for the duration of the show.
7. My enclosed check represents a commitment to show. Once accepted, I understand that any exhibitor who fails to appear one hour before the show opening forfeits his or her right to exhibit without refund or recourse.
8. I will not hold Artisan Promotions, Inc., its agents, employees or officers liable for failure to perform or fulfill its contractual obligations provided such failure is caused, occasioned or impeded by closure of the site location due to any causes beyond its control. Nor will I hold the promoter or owners or managers of the exhibit hall responsible for loss or damage of exhibitor's wares, exhibits or personal property or for loss or injury caused by projects sold or exhibited by exhibitors directly or through warranty express or implied. Insurance for such loss, damages or injury will be my sole responsibility.
9. If my check is returned due to insufficient funds, I agree to replace it with a money order or teller's check, or to forfeit my place at The Christmas Festival.
10. It is agreed that Artisan Promotions, Inc. reserves the right to amend and/or add to the applicable rules pertaining to and governing this show at any time prior to the commencement of said show.
